

UNITED IN FAITH LUTHERAN CHURCH ANNUAL CONGREGATIONAL MEETING MINUTES SUNDAY, FEBRUARY 12, 2023

The meeting was called to order by President Kim Childress at 11:06 AM.

A quorum of 29 voting members was established. Rev. Robert Goldstein (supply pastor) led us in an opening prayer.

Adoption of Agenda: Added Pastor transition to New Business. Rich Guzik moved to accept the agenda as amended. Passed.

Adoption of Annual Meeting Minutes of February 28, 2022: Note that there was an error in the Nominating Committee section (with the same person listed as moving and seconding the motion). The motion passed, and including the name of the person seconding a motion is not required. Rich Guzik moved to accept the minutes as amended. Passed.

Council President's Report: Kim Childress presented her report, stating that it was an interesting year, with discussions on electric vehicle charging stations and the resignation of our pastor. Additional details are in the annual meeting packet. Kim Childress closed her remarks by stating it was a pleasure to serve as council president.

Pastor's Report was provided by Rev. Carla Thompson Powell prior to her departure and is in the annual meeting packet.

Audit Committee Report: The audit for 2022 will be done at a later date. The Audit Committee does not have enough people to perform an audit at this time. Rich Guzik volunteered to join the Audit Committee to assist in the upcoming audit.

Treasurer's Report: Peter Herberg gave the report. We had \$138,966 in church operational income for 2022. Special gifts were \$74,218. Expenses were \$272,671, leaving a deficit of \$89,487. Our general investments had a total loss of \$40,647, including the education fund loss of \$47,279. The general Thrivent Harriet Kurz fund had a loss of \$38,149, and the ELCA ministry growth fund had a loss of \$28,761. United in Faith experienced a total loss in 2022 of \$254,823. Rick Guzik moved to accept the Treasurer's report subject to audit. Passed.

2022 Proposed Budget: Peter Herberg gave the report. The proposed income budget is \$110,800. The special gifts budget is \$40,000 due to United in Faith being the sole beneficiary of an insurance policy from the Harriet Kurz Estate, and one additional payment is expected in 2023. investment income assumes a 6.2% return. The \$74,530 investment income budget is higher than last year. The expense budget is \$285,760, which is higher than last year's budget by \$7,248. Salaries and Benefits are budgeted higher in 2023 budget due to synod guidelines. 2023 Budget assumes % time for a pastor and a modest increase for other employees. The increase in the 2023 Administration budget is due to a 15.2% increase in insurance costs (due to industry cost increases that are not specific to United in Faith). Maintenance Expense budget is the same as in 2022. The 2023 Outside Musicians budget has stayed the same as in 2022. The total budget for 2023 is \$285,670. Gretchen Quillin moved to adopt the budget. Passed.

New Business: Process for replacing Rev. Carla Thompson Powell has begun. The synod will provide interim pastors for us to interview. Executive Committee on council will interview the Interim candidates and will select that person. Additionally, United in Faith must provide forms on our ministry profile before the synod will open the permanent position to applicants. United in Faith needs to put together a Call Committee. The Call Committee will be voted on at a later date. Total timeline until hiring a new pastor is expected to be about a year.

Motion to Adjourn: Gretchen Quillin motioned to adjourn. Passed. The meeting was closed with the Lord's Prayer. Meeting adjourned at 11:41 AM.

Pastor's Annual Report

2023 has been a year of being "in the now and the not yet". In January, Pastor Carla Thompson-Powell became an Associate to the Bishop and Director of Evangelical Mission in the Metro-Chicago Synod. Pastor Robert Goldberg provided worship leadership in February and much of March. On March 20, I became your interim pastor.

While this is a time limited role, the work of United in Faith is not. Your welcome to me and my family was heartfelt and deeply appreciated. Palm Sunday was **April** 2nd and Holy Week was a whirlwind of activity, including the death of Sue Wilfong. Sue was a long-time member of United in Faith, whose love of this church was well known. She was introduced to me as a poet and shared her gifts with us even in her passing. Her death on Good Friday was not unexpected, but her presence is greatly missed.

On Easter, April 9th, United in Faith celebrated 25 years as a congregation. Bishop Yehiel Curry preached a service of Resurrection and stayed to share stories and food afterward. The eight congregations that merged to form this congregation are commemorated again by the banners they created at the end of their ministries. They hang high in the fellowship space still.

Each new season has brought a re-arrangement of the physical layout of the sanctuary. Sometimes the shifts have been small, other times substantial changes to the seating and the altar area have appeared. Always seeking to center the Eucharist, the first move was to put the alter directly under the cross on the south wall and align the lectern to visually support the table rather than overshadowing it. Congregational seating has been adjusted to allow for better line of sight for the streaming camera, and to help people see worship from new angles throughout the worship year. The congregation has been remarkably jovial about these changes.

May was a month of getting to know each other. Gracious conversations introduced me to many of you as we settled into the season of Easter and God's promise of living salvation.

Pastor Manoj Gunthoti preached and presided on Pentecost. He is serving as a new Mission Developer of Mosaic Ministry on North Avenue and Oak Park Avenue. He and his wife Smitha are ordained pastors, originally from India. They brought the good news and word new ministry to the neighborhoods south of us.

June brought the death of another long-term dedicated congregation member—Joe Childress. Joe served on several committees most notably the property committee. He was the go-to-guy for all things physical plant. He and his family served as the altar guild for many years and "Joe would know where that is," will be heard echoing in our building for years. His funeral on June 6th, filled the sanctuary. More than 200 people attended the service, as witness to his ministry and care to the communities he loved.

The Book Club read Ibrim Kendi's **How To Be An Antiracist.** We decided to keep the conversation going during July and August. Those conversations were challenging, but also revealing of the work members have done and hope to continue doing for increased awareness and channeled activity.

The Transition Team met in June and began the work of discerning UiFs strengths and needs to match with a new pastor. The team includes Claus-Peter Herberg, Dian Hoyem, Bonnie Maginnis, Mary Haas, Dave Quillen, Elizabeth Wittman and Kim Childress.

The month of **July** was also full. Throughout May, June and July I sought to understand UiFs relationship with St. Cyprian's Food Pantry. There were several areas that benefitted from improved communication with them and their Board. Learning about building needs from their end and presenting amp2023.docx

concerns from our end, helped us to relieve some of the tension that had evolved between us. I learned how they continue to serve 170 families each week and that our space is a blessing to that ministry. Although the Covid pandemic has largely passed us, people continue to struggle to meet basic food security and depend on the pantry. I shared our concerns about the energy consumption of the freezers and the cooling equipment. This encouraged them to audit and replace some of their older freezers for more energy efficient equipment. I check in with them on a regular basis and attend their quarterly Board meeting. They have welcomed me and strongly voiced their appreciation for this regular communication. I have urged them to consider adding United in Faith's Pastor to their board to further solidify our relationship, they have agreed to do so.

The Immigrant situation in Chicago reached a new level in July and several organizations in our area ramped up action and information sessions. Janeen Devine connected us with those groups, most particularly the Immigrant Resource Fair thru Wright College and a pilot of Children's Story time. The Fair was well attended, and our contributions were helpful. The Children's Story time was not as successful, but it revealed that transportation is a factor for new immigrants and services that require they come to us are less helpful.

I attended the ELCA Rostered Leaders Gathering in Phoenix. I engaged other pastors and gained insight into some of the issues congregations in other regions are navigating. Supporting immigrants and addressing poverty were the focus of several of those conversations. I was also privileged to experience a land acknowledgement discussion that centered on the Arizona region and hear the impact of that how that simple acknowledgment provided hope for native people seeking greater recognition of the effects of westward expansion and genocide of native people in the United States. This was a powerful experience.

On July 30th, the first congregational Transition Team gathered 24 people for lunch and conversation. We explored the nature of inward looking and outward looking groups. The energy was high and promising.

August was a slower month. The Chicago heat turned up and our activities slowed down. Carolyn Doughty spear headed a team to provide cool drinks and cookies to patrons waiting to receive food from St. Cyprian's Pantry. On August 28th, Carolyn, Bonnie Maginnis, Harold Edmundson and I served lemonade, water and cookies to more than a hundred people. We shared welcome and had several prayer requests for people who were suffering with health concerns.

Personally, I was diagnosed in late August with endometrial cancer. This was a startling diagnosis but relieving to have a reason for my increased fatigue over the proceeding months. Surgery was scheduled for October 2nd.

In September, banners were installed over the front LED sign to highlight our Sunday morning worship time. We celebrated the Seasons of Creation in Sunday worship. As part of that focus, I connected with the Dunning Read Natural Area volunteer team. They are revamped and recommitted to return some of the land across Irving Park Road to native marshland, for both the ecosystem and the neighborhood's health. Opportunities to support that restoration are available to the congregation and the Girl Scout troop.

Jeanne Rice took a much needs vacation in September. Her steady presence during the time between Pastor Carla and my arrival was extraordinary. She ran the office and supplied Pastor Bob Goldberg with excellent support in February and March. She also brought me up to speed and continues to serve United in Faith faithfully. I deeply appreciate her knowledge and willingness to fill in gaps. She is a blessing.

On September 16th, John Allanson was memorialized at United in Faith. Married in our Sanctuary we also provided space for his service. A Chicago Policeman, the Police Chaplain and I presided. A bagpiper added the pipes to send John home.

On **October** 1st, we dedicated the Children's Classroom Mural. Jeanne Shira's creativity and skill are plainly visible in that space. She attended through FaceTime and received our thanks and affirmation. The children's classroom currently serves throughout the month when child accompany their adults to meeting and events.

My surgery on October 2nd, meant I was homebound until October 19th. Pr. Julie Boleyn graciously supplied the pulpit and allowed me to heal confident that the Church was hearing the Good News on Sunday morning. I am so grateful to her, and to you all for your ability to flex during this time. Council also graciously postponed the October Council meeting a week to allow me to easy back into that week. Thank you!

The office hours shifted in October to better navigate around the increased traffic during Food Pantry Hours. Previously they had been Monday, Wednesday, and Thursday 10-3. From October 2nd they are Tuesday and Wednesday 9-5pm. Those are Jeanne Rice's hours. I am generally in the office Wednesday and Thursday 8:30-2:30 unless visitations draw me away.

On October 29th, we celebrated Reformation with a worship festival and an Octoberfest style lunch. The entire music team was present and let out all the stops! It was a lovely day of singing and laughter!

In **November**, we assembled an ofrenda for All Saints Sunday and congregation members brought photos and tokens to remember the Saints in our families and congregation. We kept the table and photos up through November.

As the temperatures fell, I continued to serve coffee and pastries to Food Pantry patron Monday and Thursday mornings. This will continue until spring brings warmer temperatures.

Giving Sunday was November 19th. Special thanks to the Stewardship Committee for their stalwart efforts. Gretchen Quillen, Rich Guzik and Denise Boyer deserve our deepest appreciation!

Richard Trost, our keyboardist who served United in Faith for many years, bid us goodbye. His gifts and presence were a blessing to us. He is missed, but we wished him joy and hope his ministry continues to serve God in a new place.

December is always a busy month for Church, particularly the last two weeks. This December was no exception! On December 2nd, a mighty team gathered to decorate for Advent. They put up the tree and the lights, hung banners and angels and set the Nativity set in place under our Communion Table. We celebrated the four Sundays of Advent, making straight the way of the Lord!

Every Wednesday 4-9 folks gathered to celebrate Holden Evening Prayer.

On Thursday, December 21st, we gathered to acknowledge that Christmas is a complicated season and many of us experience grief and loss most acutely as the light twinkle and the music swells. Our Blue Christmas service was on the longest night of the year and five of us gathered to lift our hearts and share some of our grief.

December 24th was both the last Sunday in Advent and Christmas Eve. So our 10am service allowed us to light the final blue candle and our 11 pm service was the first time the ring was lit and the center Christ candle heralded the birth of our Lord.

We gathered again on Monday, December 25th to sing praises and wish each other a Very Merry Christmas.

The December 31st Lessons and Carols Service was led by Council President, Claus-Peter Herberg.

Through it all Lois Cornils covered each Sunday and anchored both the Choir Sundays and the Band Sundays. As always, she was gracious every Wednesday and Sunday. I feel great appreciation for her gifts as a musician and her presence in our space. She deserves your vocal acclaim and thanksgiving. Jane Shira, Dave and Gretchen Quillen's dedication to music and technology in this congregation are astonishing. Jane creates the Sunday worship morning slides. Dave masters the Sound and Gretchen wrangles our electronic public face. If you aren't aware of all they do for United in Faith, please watch them on Sunday morning. Their love of this place is apparent each and every time.

Special thanks to Gretchen who bakes our communion Challah and allows me to speak the truth as I say: Taste and see that the Lord is good.

Band members Tim Stine and Kurt Anderson round out the music team. Tim's acoustic guitar adds a fullness to our sound that makes my heart sing. Kurt provides a steady rhythm that keeps us moving. I am grateful to all the players who share these gifts with us and allow our congregation to worship through music.

As you can see, much has happened at United in Faith this year! I am grateful to be your Pastor during this time. Please receive my heartfelt thanks to each of you for your kindness and your devotion to be God's hand and feet and voice on Irving Park Road.

2023 Council President Report February 25, 2024

What a year. We all found out in January that Pastor Karla was leaving us for a position with the Synod as of February 1, 2023. After consenting to being the Church Council President right after the Annual Meeting, my first responsibility was to work with the Synod to secure an Interim Pastor and secure Supply and Pastoral Care Pastors until the Interim Pastor starts. A special thanks to Pastor Bob Goldstein for being willing to preach most Sundays until an Interim Pastor was found.

In early March, the Church Council interviewed the Synod's recommendation, Jeanine Reardon for the Interim Pastor position and afterwards, she was accepted by the Council. Interim Pastor Contract negotiations followed, and Pastor Jeanine started in mid-March 2023. The first couple of weeks of her tenure included onboarding her and getting the Sanctuary and Fellowship Hall ready for Bishop Curry's visit on Easter Sunday.

Also, early March included coordination of the Messy Church Seminar at United in Faith, given by Messy Church's Ronda Bower that included lunch. We had people come from Michigan & Indiana for this event. A special thanks to Lois Cornils, Gretchen Quillin, and Julie O'Donnell-Lozich for helping put the seminar together.

Bishop Curry came and preached on Easter Sunday in April where many pictures were taken and put on the website. A special thanks to Rich Guzik for helping with this.

The next couple of months included analyzing what the City of Chicago wanted from us to be a grantee for the Electric Vehicle Charging station grant. After careful consideration, the Council decided not to proceed further with the application. Also, during this time frame, the Transition team met several times where the group worked on the "Cycles of Blessings" seminar from the Kaleidoscope Institute. In September Pastor Jeanine found out that she was going to need surgery and would not be at church for 2 weeks in October. A special thanks to Julie Boylen for presiding on the 2 Sundays after Pastor Jeanine's surgery.

During Pastor's recuperation, coordination was done to put together the Reformation Sunday Festival event, inviting friends & family to it as well as helping to put the Octoberfest meal together with red carnations on each table. Our efforts brought a large crowd together that Sunday. A special thanks to our musicians, Elisabeth Wittman, Janeen Devine, & Gretchen Quillin for helping to put this event together.

In November, we had to unfortunately say good-bye and God speed to our long-time musician, Richard Trost as he decided to take a full-time position closer to where he lives. We will miss him dearly. The year ended with my being the leader for our Lessons and Carols Sunday.

Thank You for allowing me the opportunity to serve as your Council President this last year.

United in Faith Lutheran Church Year 2024 Proposed Budget

Income-

The 2024 budget for Total Income from Operations, \$110,800, is \$9,888 higher than actual 2023.

The 2024 budget for Special Gifts is \$150,000 due to United in Faith's estimated final distribution from the Harriet Kurz Estate.

Investment income assumes a 6.4% return. The \$74,530 investment income budget is the same as the 2023 budget due to lower investment balances at the beginning of 2024.

Expense-

The actual Expenses for 2023 were below budget in all areas. The 2024 budget for Expenses is \$423,717, which is \$137,957 higher than the 2023 budget (\$260,561) due to the proposed \$135,000 New Roof & Brick Work project in 2024.

Salaries and Benefits are budgeted higher in the 2024 budget due to synod guidelines. The 2024 budget assumes a 3/4 time Pastor for the entire year to reflect normal operations 2024 reflects modest increases for our employees.

The increase in the 2024 Administration budget is due to a 9.8% increase in Insurance costs.

Though the 2023 actual Maintenance Expense line under Building is far lower than the 2023 budget, the 2024 Maintenance budget was left at \$20,000 in case other repair expenses come up in 2024.

The 2024 Outside Musician budget has stayed the same at \$20,000.

Change in Net Assets-

As a result of the above, the 2024 proposed budget results in a total net decrease in Total Assets (bottom line) of (\$88,387) of which (\$135,000) is due to the proposed New Roof & Brick Work. This compares to the 2023 budget decrease of (\$60,430) and the 2023 actual net decrease of (\$61,439).

THE PROPERTY COMMITTEE United In Faith Lutheran Church

It always feels like these Property reports read the same every year with a review of all the problems and issues around UIF. It's always a roof issue or a HVAC issue. If you look at previous annual reports, it's all the same problems, except the year that the truss cracked. That was something entirely different, and of course the Covid year was pretty lean on any kind of issues since we weren't in the building much. The reason it's always the same is that we have four roofs and four HVAC units that heat and cool both buildings. We have two water meters, two gas bills, two electric bills, one security system with four cameras, and one phone bill. So many expenses for one church and so many things to maintain for one church with two buildings. In this report, you will hear about these issues that occurred in 2023, and how this committee resolved, repaired, or maintained each and every component involved. As issues get addressed, we spend money to maintain, but seldom do we reap the benefits of seeing something new and feeling good about it, except when the heat gets fixed in the winter and we go from 56 degrees in the office to a balmy 68 degrees. That's satisfaction and always money well spent.

We started 2023 on a good foot with the St. Cyprian's Food Pantry. For years we have been asking them to "de-clutter" and stop collecting non-food items for the pantry. There is limited space in that building and it also presented a fire trap in some of the rooms. By January, most of the items have been removed and the clean-up was a wonderful welcome for UIF and the west building. The water meter that supplies water to the west building needed to be replaced, as well as the deficiency valve that is inside the west building near the Food Pantry's office. Both jobs were completed and a trap door to the inside valve was modified for easier access.

The Boys Scouts are no longer using the west building and they have returned all keys to United in Faith but left some of their scout gear in their storage room. Apparently when a troop "folds" it becomes property of the host church. The west building produces lots of traffic with the food pantry thus causing wear and tear on the rear door push bar. It may have been too many shopping carts hitting the door, or just the large flow of traffic, either way we needed to have the push bar replaced. The exhaust fan in the west building continues to run almost constantly so we have asked St. Cyprians to check the thermostat on the fan, or replace the fan since the electric bill keeps going up, most likely due to this fan.

The east building has had its fair share of issues too. Heavy rains in February and March brought water into our sanctuary in places we had not seen before. Buckets, towels, and shop vacs were used to clean up the water but it wasn't until late March that we found the reason for the water was clogged gutters on our barrel roof. Once the gutters were cleaned out, it solved the water issue. The roofer made us aware of an issue with our AC unit. One of the HVAC units over the east building was at risk with the wood supports beans slipping from the unit. We needed to wait for better weather and then have the structure reinforced to support the unit. Work completed.

We continue to have leaks on our roof in the front of the east building but we are still dealing with an insurance claim for weather damage. We have been working with Ed Schram from Capital Roofing, who helped us file a claim with Brotherhood Mutual almost 18 months ago. The east roof will be taken care of this spring once we complete some much needed masonry work on the capstones and bricks above the roof level. Once this is completed, we will move forward with the roof replacement, with or without an insurance claim. We are really going to do this in 2024 even though we said it would be 2023. We can't wait any longer for this.

Other property issues were graffiti on our garage door, pilot light on kitchen stove needed service after being shut off for years, talk of EV stations at UIF, alarm issues, video camera updates, new exterior vinyl sign in front, new phone system, annual sprinkler and alarm system inspections, quarterly HVAC maintenance checks, back-flow valve inspection, snow removal agreement, and a new utility cart for Steve to use. What are we missing? We meet at UIF every month to discuss all of these issues and try to accomplish all the needed tasks for our church. We would love to have new members on this committee so if you are interested, feel free to talk to one of our members.

So in 2024 it would be nice to spend some money on something that might make us feel good about UIF. You know that feeling when you go out shopping and buy something for yourself, not that you need it but that you really want it. It makes you feel good. The Property Committee is talking about replacing the 25 year old carpeting in the east building in the lounge area and front offices. The old carpet has reached its life expectancy and can no longer be cleaned. After repairing the masonry work and roof in the east building, let's "treat" ourselves to some new décor, not because we need it but because it will make us feel good about our worship space.

The 2023 Synod Assembly was held this year on June 3rd at the Q Center in St. Charles, IL. Your voting members from United in Faith were Pastor Jeanine Reardon, Mary Haas & Pete Herberg. We met with the other Synod Congregations with a Mission Statement Shout-Out in the massive Fox River Ballroom. After the Opening Litany, Acknowledgements, Greetings, & a Young Adult video, Bishop Curry gave his report which mentioned a \$250,000 gift from Redeemer Lutheran Church in Park Ridge of which \$100,000 was given to the Carlmark Fund to establish a lay resource event in 2024. Next, we watched a video on Synodically Authorized Ministers (SAM) & Theological Education for Emerging Ministries (TEEM). Before Elections, we had to try out a new voting system via our cell phones rather than using paper ballots. Afterwards we had elections for the Synod Council, Consultation Committee & the Committee on Discipline. The Sunergos Award this year went to Ami Frick who put together this year's Assembly. Before recessing to our respective workshops, we listened to the Churchwide report given by Laura Johnson, Churchwide's Executive for Administration.

I attended the "Discipleship In Our Time" workshop. Pastor Jeanine went to the "Three Pathways: Next Steps for Your Congregation" workshop and Mary sat in at the "Launching a New Congregation" workshop.

After lunch in the Q Center cafeteria, we came back to a session on Bridges & Barriers, led by Pastor Sunitha Mortha. In this session we played bridge at various tables with different rules at each table. After each round, several people from each table were moved to a different table that had different bridge playing rules. However, the new people at each table were not told what the rules were for that table. Towards the end of this exercise, I found myself at a table where you couldn't talk. I got so frustrated from not understanding what was going on in this exercise that I was about ready to walk out of it. Which was the whole point of the exercise, as Pastor Sunitha explained afterwards. It was to show us what emotions & feelings occur when you as an outsider with cultural & language differences are put together with a group that is totally different than what you are used to.

After the exercise, we listened to the Treasurer's Report by Yvette NewberryWhite and we adopted the balanced 2024 Budget with \$3,085,833 in Income & Expense. Afterwards, we all adjourned to Bethlehem Lutheran Church, a mile south of the Q Center for a worship service presided by Bishop Curry where the bulletin was in both English & Spanish.

Seems to me the past few years can be defined as pre-pandemic, during the pandemic, and post-pandemic. We are currently looking for a part-time pianist to work on every other Sunday alternating with Lois Cornils.

Once again, we are in transition. We are continuing to record our worship services and livestream on Facebook. Many thanks to Dave and Gretchen Quillin for their work on this important area of outreach. We are looking for people who are willing to be trained on using the Mevo camera so that we can livestream when Gretchen and Dave aren't available. Pastor Jeanie has been encouraging the Worship and Music Ministry to think about the big picture and what's next. One area we are focused on is improving the livestreams. For a long time, the only people heard were the pastor, the worship assistant, and the musicians leading worship. Recently Dave Quillin purchased ambient microphones for the sanctuary. Many thanks to Dave Quillin and those who helped him install these mics. When I watched the livestream recently, people in the congregation were heard singing, speaking, and praying together. Hearing the congregation in the livestream made it feel more like being at a Lutheran church service.

We will be looking for feedback from the congregation about what you like and/or dislike about our current worship services. Thanks to all the people serving as worship assistants and on the Altar Guild this past year. Also, many thanks go out to our worship and music planners: including Lois Cornils, Dave Quillin, Denise Boyer, Janeen Devine, Katie Jewell, and Elisabeth Wittman, who with our pastor's guidance, all volunteer their time.

Communion Visitation - bringing the church to members and friends who are unable to attend Sunday morning worship services on a permanent or temporary basis, enabling all to remain connected to the ministry of United in Faith.

Communion Visitation ministry activities demonstrate all of our guiding principles: proclaiming Jesus is Lord and Savior, reflecting God's love, praying and listening for God's guidance, continuing to strengthen faith, including all in God's work and meeting people where there are. Our main activity is visitation during which communion is given, printed devotionals are provided and information regarding United in Faith is shared. In some cases, telephone calls are routinely made instead. Weekly bulletins and monthly newsletters may also be mailed or delivered. Those visited are included on the Prayer Weaving. In these ways we are being 'God's hands, feet and voice' as we care for each other.

Members of this ministry are Pamela Marino, Terrie Miller, Barbara Patrick and Elfriede Reiss. In addition to regular monthly visits, visits are made as needed to others in situations such as hospitalization. Pastor Jeanie also makes these special visits.

The number of regular monthly visits made this year was limited to one due to the loss of those being visited (death, health, moving) and the return to church by some. Several people are designated as being 'visit on request' status.

Anyone with a passion for helping those unable to attend worship services stay connected to United in Faith is invited to join us in our 'caring, communing, listening, loving and providing' ministry. You can become involved in a number of ways (as restrictions allow or are lifted):

- *become a visitor* a wonderful opportunity to share your faith, listen to life stories, pray with others, sit and visit awhile, bring the bread of life and cup of blessing;
- *notify* the church office when you or someone else is no longer able to attend worship on a permanent or a temporary basis so a visit can be scheduled if it is desired;
- *pray* for those visited (all are listed on the Prayer Weaving) as well as for those who are doing the visiting; and,
- *telephone, send a card or visit* someone who is unable to come to church.

NEW LIFE FOR OLD BAGS United in Faith Lutheran Church 2023 Annual Report

New Life for Old Bags (NLOB) is a completely volunteer run group working together to make sleeping mats for the homeless. The creation of each mat takes 80 volunteer hours and repurposes 700 used plastic bags. The handmade mats provide the homeless with some cushion, water resistance, and love. Completed mats are shared with non-profit organizations who directly work with homeless populations for distribution in the City of Chicago and local suburbs.

NLOB was founded in Chicago in February of 2010 and has its headquarters at United in Faith (UIF). It has grown, and now we have Chicagoland Chapters at Friendship Village in Schaumburg, Plano, and Plainfield. There are also "chapters" all over the United States such as Wooster, Ohio and Las Vegas, Nevada, and beyond. In 2024, we will reopen our Chicago East campus at Midwest Buddhist Temple.

NLOB is very grateful to UIF for providing office space for what we like to call our "main campus" and space for monthly NLOB work day parties which also serve as the training grounds to teach new volunteers about our project.

As we continue to adjust after the pandemic, we are still navigating challenges. We continued in person monthly workdays in 2023. We meet on the first Saturday of each month from 10am to 12pm excluding January, July, and September. While we do not have as many volunteers come in person as we used to, we do have many volunteers working the project at home and dropping off their completed work during these monthly work days. For 2024, we are going to reduce our frequency of meeting to every other month, only meeting on the even months in February, April, June, August, October, and December.

By the end of 2023, NLOB volunteers will have donated 529,520 hours (37,360 of those hours were given from 1/1/23 to 12/31/23), creating a total of 6,619 sleeping mats (467 of those mats were made from 1/1/23 to 12/31/23), sharing love with local homeless by giving them a mat to sleep on, while repurposing over 4.6 million plastic bags to date (keeping them out of landfills and water sources). NLOB has continued our collaboration with Chicago Lights out of 4th Presbyterian Church in Chicago. Chicago Lights serves the homeless among other populations in need. NLOB was able to deliver close to 100 completed mats to Chicago Lights to distribute to the homeless in the City of Chicago.

UIF has provided us with a home office, storage space, resources, and support that has allowed us to continue to grow, collaborate, serve the homeless, benefit the environment, develop relationships, and build community.

Constitutional Amendments



January 23, 2024

Dear Members of United in Faith Lutheran Church

At our Annual Meeting on February 25, 2024, 2 proposed changes to the Constitution will be presented under New Business.

The 1st proposed change is to add to Chapter 11.01, a subsection (C11.01.03) concerning Officers who are to be automatically included on the bank's signatory cards. (See attachment below).

The 2nd proposed change is to change the wording of Chapter 13.03 concerning Audit Committee membership ineligibility if one is authorized to sign checks. (See attachment)

1. **Chapter 11: OFFICERS**

Add the following section

C11.01.03. The treasurer and financial secretary shall be members who are automatically listed on the bank signatory cards. The Congregational Council may authorize other members to be added to the bank signatory cards and also may remove other members from the bank signatory cards.

Rationale:

This section documents who are automatically to be listed on the bank signatory cards based on their position. This section also documents who is authorized to add other members to and/or remove other members from the bank signatory cards.

2. **Chapter 13: CONGREGATION COMMITTEES and MINISTRIES**

Currently reads:

C13.03

The Audit Committee, composed of three voting members, shall be elected by the Congregational Council and shall not be members of the Congregational Council. Terms of office will be two years, with one member elected in even numbered years and two members elected in odd-numbered years. Members shall be eligible to serve no more than two (2) terms consecutively. The Audit Committee shall:

- Audit financial records of this congregation at least annually.
- Submit a report to the Council prior to the annual meeting and to the Congregation at the annual meeting.

Proposed change:

C13.03

The Audit Committee, composed of three voting members, shall be elected by the Congregational Council and shall not be members of the Congregational Council a member who is authorized to sign checks or a family member of one who is authorized to sign checks or one who lives in the same household of one who is authorized to sign checks. Terms of office will be two years, with one member elected in even numbered years and two members elected in odd-numbered years. Members shall be eligible to serve no more than two (2) terms consecutively. The Audit Committee shall:

- Audit financial records of this congregation at least annually.
- b. Submit a report to the Council prior to the annual meeting and to the Congregation at the annual meeting.

Rationale:

By allowing members of the Congregational Council to be an auditor, it makes more people available to be an auditor. By not allowing those who live in the same household as a designated check signer to serve on the Audit Committee, eliminates the possibility of a conflict of interest of those serving on the Audit Committee.
