

Annual Congregational Meeting Minutes of February 23, 2025

The meeting was called to order at 11:14 AM

Quorum: A quorum of 25 voting members was established.

Devotions: Pr. Jeanine led us in the Lord's Prayer.

Adoption of Agenda: Under new business add section b. Global Refuge. Denise Boyer moved to accept the agenda as amended. Rich Guzik seconded. Passed.

Approval of Annual Meeting Minutes of February 25, 2024: Gayle Guzik noted corrections to be made. In the paragraph that begins: Amendment in audit procedure...In the second line strike "open conversation on" Insert: amend. After that sentence insert a new sentence: "The motion was seconded". In the first line of the next paragraph strike "open conversation on". Insert "amend". After that sentence inset a new sentence: "The motion was seconded. Dave Quillin moved to accept the minutes as amended. Rich Guzik seconded. Passed.

Constitutional Vote Meeting Minutes held June 30, 2024. Dave Quillin moved to accept minutes as written. Rich Guzik seconded. Passed.

Call Committee Vote Meeting Minutes held November 10, 2024. Denise Boyer moved to accept the minutes as written. Rich Guzik seconded. Passed

Council President's Report: It is in the annual meeting packet. Gretchen Quillin said it has been a busy and interesting year. She thanked the congregation for showing the love of God to each other. She also thanked those who served with her this past year, the transition team, and Pr. Jeanine.

Pastor's Report: It is in the packet. She can see "the light at the end of the tunnel". She is grateful for God's mission in the church and grateful for everyone.

Audit Committee Report: The audit committee report is in the packet.

2024 Treasurer's Report: Peter Herberg gave the report.

We had an income of \$95,088. Special Gifts of \$542,666. This gives us a total of \$637,754. Expenses were \$448,429 leaving a balance of \$189,325. This gives us an increase of \$287,868. There was no motion taken.

2025 Proposed Budget: Peter Herberg gave the report:

The proposed budget is \$100,800 is \$5,721 higher than actual 2024. Special gifts is \$150,000 due to United in Faith's estimated continued final distribution from the Harriet Kurz Estate.

Investment income assumes a 6% return. The \$82,320 investment income budget is higher than last year due to higher investment balances at the beginning of 2025.

The expense budget is \$341,261 which is \$82,456 lower than last year's budget due to the new roof, carpeting & painting projects completed in 2024.

Salaries and Benefits are budgeted higher due to synod guidelines. The 2025 budget assumes a full time Pastor for the entire year to reflect the congregation's guidelines for the permanent Pastor position. 2025 reflects a modest increase for our employees.

The increase in the 2025 Administration budget is due to a 9.6% increase in Insurance costs caused by higher building replacement estimates.

2025 Maintenance Expense line is far higher than the 2024 budget due to the new carpeting & painting expense. The 2025 maintenance budget was left at \$20,000 in case other repair expenses come up in 2025.

The 2025 Outside Musicians budget has increased to \$25,000 as we look to hire a pianist.

The 2025 proposed budget results in a total net decrease in Total Assets of \$8,141.

Dave Quillin moved to accept the proposed budget as the actual budget. Rich Guzik seconded. Passed

After the paragraph supports efforts...add another paragraph: commits to racial equity and anti-racism. In the last paragraph change core values to purpose and guiding principles.

Katie Jewell moved to approve the welcome statement as amended. Rich Guzik seconded. Passed.

- b. Global Refuge organization: The Council has approved a \$5,000 donation to this organization.

Motion to Adjourn: Mary Haas moved to adjourn. Kim Childress seconded. Passed.

The meeting was closed with Pastor Jeanine leading us in the Lord's Prayer.

Meeting adjourned at 11:45 AM.

Pastor's Annual Report - 2025

2025 was a full year. A busy year. A year of showing up—sometimes with energy and enthusiasm, sometimes a little tired, sometimes unsure—but still showing up. Together.

God kept meeting us right where we were. In hospital rooms and kitchens. Around soup pots and prayer tables. In worship circles, pickleball courts, council conversations, and long emails about logistics. Not always where we planned to be—but faithfully, lovingly present nonetheless.

Pastoral Care: The Holy Work of Showing Up

Pastoral care in 2025 took many forms. There were home visits, hospital rooms, phone calls, office conversations, funerals, baptisms, and the kind of check-ins that don't make headlines but hold people together. Some were scheduled. Many were not.

Alongside care within our congregation, we were also invited—more than once—to respond quickly and compassionately to needs beyond our walls. Most notably, United in Faith responded generously to support a Venezuelan family navigating harassment, housing instability, and the everyday stress of uncertainty. Through grocery cards, rent assistance, school supplies, and partnership with other ministries, you showed up with care that was practical, relational, and deeply faithful.

This, friends, is what it looks like to be church.

Worship: Gathering, Even When Life Is Full

Worship remained the heartbeat of our shared life. We gathered on Sundays and midweek evenings, in seasons of quiet reflection and joyful proclamation. When illness or travel required flexibility, others stepped in with grace, ensuring that worship continued to be a place of welcome and steadiness.

Lent invited us into Holden Evening Prayer—simple, beautiful, and grounding. Sitting in the round, sharing joys and concerns, many of us found that this quiet rhythm became a gift at the end of long days.

Holy Week and Easter, Advent and Christmas, Seasons of Creation and ordinary Sundays—all of it reminded us that worship doesn't exist apart from real life. It meets us inside it.

The band brought their hearts and dedication through Lois's treatment and ongoing recovery. And music continued to be a steady anchor throughout the year, offered with flexibility, creativity, and deep care.

Faith Formation: Soup, Joy, Prayer, and Honest Conversation

Some of the most meaningful moments this year happened around tables.

During Lent, Soup and Conversation invited us to explore *The Book of Joy* alongside the wisdom of the Dalai Lama and Archbishop Desmond Tutu. Joy turned out to be slippery. Not a feeling we could manufacture, but something that often showed up right alongside suffering. Over five weeks, trust deepened, conversations grew braver, and laughter—along with excellent soup—found its way into the mix.

Midway through the year, we re-engaged our Prayer Ministry. A small but faithful group began meeting weekly to pray for one another, for the congregation, and for a world that often feels overwhelming. No fancy language. Just steady, honest prayer—the kind that knits us together over time.

Outreach & Justice: Loving Our Neighbors, Practically

United in Faith continued to live into its calling to be God's hands, feet, and voice in the world.

Support for St. Cyprian Pantry took many forms—fundraisers with local restaurants, logistical problem-solving behind the scenes, and the joyful success of the *Empty Bowls* fundraiser, which raised over \$5,000 to address food insecurity in our neighborhood. Katie and Janeen mustered their Girl Scout troops, provided warm hospitality and demonstrated how they get things done.

In September, *God's Work. Our Hands.* brought us together with partner congregations at Acacia Park. We assembled fleece blankets for Phil's Friends, prayed over each one, and shared stories—reminding us that ministry is often born where compassion and collaboration meet.

We also engaged in honest discernment about ministries that may be changing or ending, including *New Life for Old Bags*. Naming fatigue, honoring what has been, and asking faithful questions about what comes next is holy work, even when it's tender.

Congregational Life: Joy, Movement, and Milestones

Not everything was heavy.

Pickleball happened. (Repeatedly.) There was laughter, light-hearted competition, minor injuries, and a surprising amount of joy. Potlucks, shared meals, prayer gatherings, and simple moments of fellowship continued to nurture connection.

We welcomed new faces, new voices, new talents and a new member. We celebrated milestones—including Lenore's 101st birthday—and gave thanks for and to beloved members preparing for new chapters. These moments reminded us that church is not static. It is a living, breathing community, shaped by seasons of arrival and departure.

And in the gardens, new shoots and branches will join the rocks in hope. Judy and Elisabeth brought their dedication and green thumbs to the greenery around the building. Together we roped all sorts of folks to move soil, and shrubbery and ROCKS. I can't wait to see how God's abundance will grow in those spaces.

Leadership, Transition, and Trusting What's Next

As the year unfolded, important conversations emerged about leadership, structure, and shared responsibility. With fewer people doing more, we began asking faithful questions: Where are the gaps? Who tends them? How do we lead together with clarity rather than exhaustion?

Alongside these conversations, the call process moved forward with hope. And with it came the tender awareness that change is always coming. Endings and beginnings often travel together.

Waiting, Watching, and Wondering

As the year drew to a close, Advent invited us—once again—to slow down just enough to notice God’s movement among us. Waiting. Watching. Wondering. These simple postures gave us practice for the kind of readiness this congregation is stepping into.

2026 has brought a new pastor to United in Faith. With her is new energy, new questions, and new opportunities to love boldly. Advent reminded us that preparing the way is not about having everything figured out—it’s about making space. Space for God. Space for one another. Space for what is being born.

So as I look ahead for you, I do so with gratitude and trust. God has been faithful to this community—again and again.

I am deeply grateful for you and for the ministry we have shared. I have loved being your pastor. I have been changed by you, by our work together. Many of you know that these reports are not my favorite partly because they never capture all the work or the hearts that do the work of the church. These snapshots of this year are only a few of the memories and accomplishments that I cherish. I trust and I know that God is not finished with you yet.

2025 Council President Report

This year, the congregation said goodbye to our interim pastor, Jeanine Reardon. Pastor Jeanie was here for almost three years as we reflected on our future and prepared to find and welcome a new permanent, full-time pastor. She cared for us and made sure that our time between pastors was time of continued forward motion. Pastor Jeanie also brought pickleball to our fellowship space, showing us yet another great use for our space. We are incredibly appreciative of the work that Pastor Jeanie did for *and* with us.

After a thorough search, the Call Committee brought Sharei Green to the congregation, and in December, the congregation voted to approve Sharei as the Pastor at United in Faith. We are excited to welcome Sharei. I truly hope you take the time to get to know her. Please join me in thanking the Call Committee for their important work: Dave Quillin (chair), Kim Childress, Janeen Devine, Jeff Jewell, Katie Jewell, Bonnie Maginnis, and Pam Marino.

In October, the Harriet Kurz Community Grant (HKCG) Program gave out its first grant to sponsor the Empty Bowls fundraiser for St. Cyprian's Food Pantry. The event raised over \$5,000 for the food pantry to assist them with feeding their clients. Grant applications are available for additional projects and organizations. In 2026, the HKCG Program has a budget of \$20,000 to distribute thoughtfully into our community. A member of the United in Faith community must provide a referral, and if you are aware of any local groups and/or projects that need a little seed money, please contact Katie Jewell for information and an application! Getting to know our community better is one of our goals for the coming year, and we have a great opportunity to make an impact beyond United in Faith in memory of Harriet Kurz, who left us a substantial amount of money when she passed.

Although 2025 did not bring major upgrades to our buildings, maintaining our facilities and property is a challenging and often underappreciated task. I am incredibly grateful for all the efforts of the Property Committee members: Harold Edmonson, Mary Haas, Harold Hoyem, Julie Lozich, and George Schultz. Though I can't thank you all by name, please know that I do extend my gratitude to all of you for the time, talents, and treasures that you lovingly pour into this dynamic and exciting congregation. It has been an honor serving as your Council President the last two years.

Year 2026 Proposed Budget United in Faith Lutheran Church

Income-

The 2026 budget for Total Income from Operations, \$101,200 is \$8,513 lower than actual 2025 due to St. Cyprian's rent payment catch-up in 2025.

The 2026 budget for Special Gifts is \$600,000 due to United in Faith's receiving a large distribution from the Harriet Kurz Estate.

Investment income assumes a 6% return. The \$120,000 investment income budget is higher than the 2025 budget due to higher investment balances at the beginning of 2026 and the addition of the large Harriet Kurz Estate distribution.

Expense-

The actual Expenses for 2025 were above budget in all areas except for Salaries, Ministry, Outside Musicians & Ministry Directors. Yet Total Expenses for 2025 is \$13,723 lower than the Total 2025 Budget. The 2026 budget for Expenses is \$409,011 which is \$67,750 higher than the 2025 budget (\$341,261) due to a projected Office HVAC replacement (\$30,000), higher projected costs in the Ministry, Administration, Building and Outside Ministry areas as well as an increase in the Outside Musicians area for performance raises and an additional pianist.

Salaries and Benefits are budgeted higher in the 2026 budget due to synod guidelines. The 2026 budget assumes a full time Pastor for the entire year. 2026 also reflects modest increases for our employees as well as a reserve, if needed (\$12,091), for an additional day per week (\$232.52) for the office administration position.

The increase in the 2026 Administration budget is due to a 5.4% increase in Insurance costs caused by higher building replacement estimates & a 66.4% increase for the Thrivent Brokerage Fee due to a larger investment pool.

Change in Net Assets-

As a result of the above, the 2026 proposed budget results in a total net increase in Total Assets (bottom line) of \$412,189. This compares to the 2025 budget decrease of (\$8,141) and the 2025 actual net decrease of (\$71,265).

We have audited the financial records of United in Faith Lutheran Church (UiF) for the year ended December 31, 2025.

Our audit consisted of examining all disbursements of \$500.00 and above, select cash receipts, bank reconciliations and payroll tax records. We believe that examining records within the above parameters allowed us to decide if the financial records are free of material misstatements.

We have audited three areas: receipts, disbursements and payroll. Our audit results are as follows:

Receipts:

Select deposits during 2025 were compared to the bank statements, deposit slips and the counter sheets. All deposits were in agreement with the counter reports. Bank reconciliations were reviewed for accuracy and completeness and were found to be in order.

Disbursements:

All disbursements over \$500.00 were examined for approval of invoice/expenditure, agreement with check for amount paid, and proper coding in the ledger. All payments appear to be proper.

Payroll:

Payroll expenses were reconciled to the budget detail report and the tax reports. There are no material differences.

Recommendations:

THE PROPERTY COMMITTEE

When I think about a new year, I think of the word “fresh”. A fresh start, full of resolutions, promises, new ideas, goals, and exciting new changes. That is exactly how 2025 started at United in Faith. We started the year with freshly waxed and polished floors, new carpet, freshly painted walls in the lounge and office areas. The appearance of UIF was looking “fresh” and clean again; very inviting to new people coming into our building.

We didn’t plan on doing too much in 2025, but we knew we had a few issues to tackle, some we were aware of, and some we were not. We didn’t realize that the small hot water tank in the sacristy needed to be replaced until it started leaking. Why did we think a hot water heater should last over 27 years? We gave two of our pianos a refresh with a professional tune-up and now it’s just music to our ears when we hear them. Steve was gifted a new salt spreader in February even though we really didn’t have much snow in 2025, but we are ready for the snow of 2026! The barrel roof above the sanctuary and fellowship hall was addressed as possible “weather related damage” to our insurance company but they reviewed the evidence twice and denied the claim for a new roof, so we went ahead and silver-coated the entire roof to give us an extra 5-7 years before we need to think about a replacement. We had our first leak in one of the corners of the barrel roof that came in right where we display our Christmas tree each year. The leak was repaired and we contracted with APR to do the barrel roof in the fall once we knew the insurance claim was denied. Even our new roofs on the east (front) and west building have been experiencing leaks since they were replaced but we were told that it might have been a drain issue.

The Property budget for 2025 was increased due to the rising costs of gas and electricity. We also made sure there was money in our budget for landscaping which was very desperately needed from construction damage to the rear courtyard in 2024. Two new carbon monoxide detectors were purchased and installed in the fellowship hall and the sanctuary. Sound planning for the acoustics in the sanctuary were discussed after an expert from Wheaton came out to evaluate the space. He suggested that the least costly remedy for the sound issue was to carpet the sanctuary to absorb the sound so that it won’t bounce off the bare walls and floors. And speaking of floors, we had the tile floor in the front corridor professionally steamed cleaned and sealed since we had never had this done since that tile was installed 27 years ago. Our rear doorbell was replaced (again). The first aid kit in the kitchen was fully replenished by Mary Haas so please feel free to use it before you call 911.

Since our Com Ed bill continues to increase we have entertained the idea of using solar panels on our roofs. We are good candidates for that but there is a hefty “upstart” cost to this. We most likely would recoup all money put into the solar within 7-10 years which got us thinking about how many of us would still be here, so we tabled the idea for later. In the meantime, we are looking into good programmable thermostats as recommended by Com Ed with the incentives of rebates.

Our office copy machine was going out of warranty on the lease, so we received quotes from Gordon Flesch Company for both a new (leased) copier and new telephone system. We contracted with T-Mobile to eliminate the landline with Comcast and install “radio” wireless for the alarm company. There are many technological changes for UIF moving into 2026.

The sewer drain in our parking lot was rodded and cleaned out thus opening up a Pandora’s Box. The water in the west building was not backing up, and everything was draining but the plumber ran into a blockage somewhere in the line under the floors in the west building. He installed an exterior clean out and he will be back in the spring to try the electric rod again through the new clean out. There is always something that needs to be repaired or replaced at UIF and our HVAC units are no exception. It appears that we will need to replace the old HVAC unit on the east (front) building that heats the office area. This unit is currently our oldest unit and thankfully not as large as the other units we own. Enterprise will be providing us with an estimate soon.

At the end of the year, an accident occurred in our parking lot which caused some damage to our brick building both on the interior as well as the exterior where the impact occurred from a vehicle that was driven by an elderly woman from a group that meets here at UIF once a week. We have an estimate for the repairs, and her insurance company will be responsible for the cost to fix the masonry in the spring when the temperatures exceed 45 degrees for the mortar to set properly.

Taking care of United in Faith is an endless job. There's always something that needs to be addressed; something that needs attention and someone to make sure things get done. This past year it was an entire team of people who did this for UIF. We personally thank Jeanne Rice, our church administrator, for being here when work is being done and people need to be let in for estimates. Jeanne, without hesitation, puts her work aside to help the Property Committee when we can't be there. We are forever grateful for Harold Hoyem who has been on this Property team for over 27 years! Harold has retired from Property but only because he moved out of the area. We will truly miss Harold and his eagerness to always help out at UIF. The heart of our property team for the past few years was Pastor Jeanine Reardon. She was a wealth of information when it came to our buildings. She went above and beyond her job description for UIF. Most of the work done here in the last few years would not have happened without Pastor Jeanine. She saw what needed to be done since we appeared to be content with the status quo. We didn't think we needed to spend money but then realized we were happy with what we did with all the beautiful renovations/improvements. We thank Pastor Jeanine for being persistent to the changes that we seemed somewhat reluctant to do. We needed that nudge that she gave us, and we will always be grateful for her as our interim pastor.

For a second year in a row, we nominate Harriet Kurz as our "angel" of the Property Committee since she continues to make miracles happen with her generosity, which makes our decisions for expensive repairs and improvements easier on our budget.

As we make a "fresh" start to 2026, we warmly welcome our new Pastor Sharei Green and hope she will join us on the Property Committee with her fresh ideas and insightful vision. We are blessed to have her at United in Faith!

SYNOD ASSEMBLY VOTING MEMBERS

United in Faith Lutheran Church

2025 Annual Report

The 38th Annual Metro Chicago Area Synod Assembly was held at the Q Center in St Charles Illinois on May 30 to 31, 2025. The Assembly was sponsored by Advocate Health Care who presented about the great work they are doing in multiple medical facilities in the area.

One of two workshops we attended was “Changing Church for a Changing World”, led by our former Pastor, Carla Thompson Powell. (Their 33rd wedding anniversary was this weekend.) The workshop was modeled after the story of some mice searching for cheese. In this context, the ‘cheese’ was ‘what brought us into church today’? The challenge is “Can we risk doing something different if we were not afraid”. Change Happens. The Good News is unchanging but the ways to show God in the world is constantly changing. Find out what lights up a person, try something new. Ask and learn about others. Value Children, don’t just ask them to sit quietly. Our new commandment is to “Love One Another”. We love them as we engage with them.

The other workshop was titled “Gathered, Re-Membered and Sent”. This workshop talked about how different cultures perceive the worship of The Creator. We are reminded that we see the Gospel through the lens of our personal history, but that limits our view. When exclusion happens, there is evil. We are called to contextualize the Gospel in a way that does not make others invisible.

We saw several videos about what other congregations were doing: St. Paul in Villa Park collects food for the Food Pantry during the annual Fourth of July Parade. People push grocery carts in the neighborhoods and folks put nonperishable items or money into the carts. In another video we saw how several congregations, each with few members, work together to share Pastors by alternating worship times.

At this Assembly we had the responsibility to elect the bishop of the Chicago Metropolitan Synod. On the first ballot, a large number of pastors were nominated. Only six got more than 9 votes, included in that number was our interim Pastor Jeanie Reardon with 20 votes. A second ballot was held and the pastors with more than 9 votes dropped to five candidates; Our Pastor Jeanie Reardon went up to 24 votes, but Bishop Curry went from 224 votes in the first ballot to 271 votes. Tension mounted as a third ballot was announced. If a fourth ballot was required each candidate would need to make a 5-minute speech to the assembly, but at the third ballot, even though our Pastor Jeanie got 26 votes, Bishop Curry won with 265 votes. In the third ballot only 259 votes were necessary for Bishop Yehiel Curry to be elected for his second 6-year term.

Also, there were ballots for Synod Council Vice-President and Synod Council Secretary as well as members of the Synod Council. Terry Henderson was re-elected to Synod Vice President and Erin Clausen was re-elected to Synod Secretary. (Some may remember that Pastor Erin Clausen was an intern at United in Faith years ago.) The members of the Synod Council stood unopposed so were re-elected by acclamation.

In attendance there were 261 Lay Voting members and 178 Rostered Voting members for a total of 439 voting members. There were also many guests who did not vote.

There were Resolutions and Memorials approved to be sent forward to the Church Wide Assembly for consideration. They will meet July 28 to August 2, 2025.

On behalf of your members who attended, we found the Assembly very interesting. We learned about some of the fantastic things going on in our synod. Our recommendation is, if you are asked to be a voting member for the Synod Assembly, consider saying, “yes”.

This past year Lois Cornils, our organist/pianist and choir director, experienced a serious health scare and had to take time off for medical treatment and healing. We were happy to welcome her back in the beginning of last December. We are grateful for her return and pray for continued good health. Our other professional musicians are Tim Stine, an excellent guitarist, and Kurt Lubbe, a great drummer. Lois and Kurt are with us every other Sunday on an alternating basis. Some services are led by just guitar, drum, and vocals alternating with services led by piano, vocals, and guitar. In my opinion, it would be great if we'd hire a part-time pianist who sings, to play and sing with the volunteer vocalists on band-led Sundays.

As always, we appreciate feedback from the congregation about what you like and/or dislike about our current worship services. Thanks to all the people who served as worship assistants and on the Altar Guild this past year. Also, many thanks go out to our worship and music planners: including Lois Cornils, Denise Boyer, Janeen Devine, Katie Jewell, and Elisabeth Wittman who all volunteer their time. Thanks to Dave Quillin for helping lead the congregation along with the band and I, and Dave and Gretchen for their work with the sound system. We are looking forward to a new year with a new pastor, and the journey yet to come.

Harriet Kurtz Community Grant Program

The Harriet Kurtz Community Grant (HKCG) Program was formally established in 2025. There are 3 congressional members as well as the Pastor serving on the committee. Our mission is to provide small seed-money for larger projects that benefit the community. Projects do not need to be run by members of the congregation, but all proposals should be sent to the committee by a member of UIF. In this way, we expand our reach into the community, but also stay connected to our roots.

The “Empty Bowls” fundraiser on October 26, 2025 was the first project supported by the HKCG Program. Tickets were available for purchase for those wanting a bowl. The event hosted over 100 guests for the meal and raised nearly \$5000 for St. Cyprian’s Food Pantry.

Communion Visitation - bringing the church to members and friends who are unable to attend Sunday morning worship services on a permanent or temporary basis, enabling all to remain connected to the ministry of United in Faith.

Communion Visitation ministry activities demonstrate all of our guiding principles: proclaiming Jesus is Lord and Savior, reflecting God's love, praying and listening for God's guidance, continuing to strengthen faith, including all in God's work and meeting people where there are. Our main activity is visitation during which communion is given, printed devotionals are provided and information regarding United in Faith is shared. In some cases, telephone calls are routinely made instead. Weekly bulletins and monthly newsletters may also be mailed or delivered. Those visited are included on the Prayer Weaving. In these ways we are being 'God's hands, feet and voice' as we care for each other.

Members of this ministry are Pamela Marino and Elfriede Reiss. In addition to regular monthly visits, visits are made as needed to others in situations such as hospitalization. Pastor Jeanie also makes these special visits.

Regular monthly visits were made to three persons and going forward there will be two. The number is fluid due to the loss of those being visited (death, health, moving) and the return to church by some. At times communion is brought to those unable to attend each Sunday on an ad-hoc basis by a congregant.

Anyone with a passion for helping those unable to attend worship services stay connected to United in Faith is invited to join us in our 'caring, communing, listening, loving and providing' ministry. You can become involved in a number of ways:

- *become a visitor* - a wonderful opportunity to share your faith, listen to life stories, pray with others, sit and visit awhile, bring the bread of life and cup of blessing;
- *notify* the church office when you or someone else is no longer able to attend worship on a permanent or a temporary basis so a visit can be scheduled if it is desired;
- *pray* for those visited (listed on the Prayer Weaving and in the Sunday bulletins) as well as for those who are doing the visiting; and,
- *telephone, send a card or visit* someone who is unable to come to church.

The Girl Scout troops at United in Faith are alive and thriving! This year we have 22 girls spread between all of our troops. There are 5 each of Daisies and Brownies, 6 Junior Girl Scouts, 4 Cadettes and 2 Senior Scouts. We are still a little smaller than we were before Covid, but we have added new girls this year. Our troops are considered “Community” troops in that we accept girls from anywhere, not just a particular school or church; in fact the girls in our troops come from over 8 different schools. Even though they come from different schools and grade levels, they have formed some strong bonds of friendship-it is really wonderful!

Some of the things we have done since January of 2025 have been: selling cookies, participating in Girl Scout Sunday, planting tomato and cucumber seeds to distribute to folks at St. Cyprian’s, the older girls went camping (over a scorching weekend), made centerpieces for the Pantry’s Empty Bowls event and had one Senior assist at the event, and assembled hygiene kits that were given to LSSI.

There were also Girl Scout Service Unit events held here for other troops in our neighborhood. We had our Thinking Day event in February and Juliette Low Rally in October where we assembled over 60 “Birthday in a Bag” kits for St. Cyprian’s families. We also hosted a Textile Arts day for some of the older girls where they learned about knitting and crocheting and tried both.

We have a lot going on, and it doesn’t always happen just on Tuesdays! Our girls have been learning a lot of different skills and having a great time thanks to our wonderful leaders and thanks to UIF for hosting us and letting us try new things!

Our current Girl Scout leaders include: Colleen Dolan and Dawn Kuswick, Daisies and Brownies. Catherine Marks and Michelle Anderson lead the Junior the Junior troop. And Sharon Kells and Janeen Devine have the Cadette and Senior Girl Scouts.

We are always ready to add girls to our troops!

New Life for Old Bags (NLOB) is a completely volunteer run group working together to make sleeping mats for the homeless. The creation of each mat takes 80 volunteer hours and repurposes 700 used plastic bags. The handmade mats provide the homeless with some cushion, water resistance, and love. Completed mats are shared with non-profit organizations who directly work with homeless populations for distribution in the City of Chicago and local suburbs.

NLOB was founded in Chicago in February of 2010 and has its headquarters at United in Faith (UIF). It has grown, and now we have Chicagoland Chapters at Chicago East Campus at Midwest Buddhist Temple, Plano, and Plainfield. There are also "chapters" all over the United States such as Wooster, Ohio and Las Vegas, Nevada, and beyond.

NLOB is very grateful to UIF for providing office space for what we like to call our "main campus" and space for monthly NLOB workday parties which also serve as the training grounds to teach new volunteers about our project.

We continued in person monthly workdays in 2025 every other month. We met on the first Saturday of each even numbered month from 10am to 12pm. While we do not have as many volunteers who come in person, we do have many volunteers working on the project at home and dropping off their completed work during these monthly workdays. *For 2026, we are in discussions about potentially ending our monthly workdays at UIF due to lack of participation and should have a decision by February 2026.* If we continue in 2026, we will maintain the same frequency of meeting of every other month, only meeting on the even months in February, April, June, August, October, and December.

By the end of 2025, NLOB volunteers will have donated 592,480 hours (32,400 of those hours were given from 1/1/25 to 12/31/25), creating a total of 7,406 sleeping mats (405 of those mats were made from 1/1/25 to 12/31/25), sharing love with local homeless by giving them a mat to sleep on, while repurposing over 5.1 million plastic bags to date (keeping them out of landfills and water sources). NLOB has continued our collaboration with Chicago Lights out of 4th Presbyterian Church in Chicago and the Homeless Outreach Group at Cityline Bible Church both of which serve the homeless among other populations in need throughout the City of Chicago and directly deliver our completed mats to homeless individuals.

UIF has provided us with a home office, storage space, resources, and support that has allowed us to continue to grow, collaborate, serve the homeless, benefit the environment, develop relationships, and build community.

**St. Cyprian's Ecumenical Food Pantry
United in Faith Lutheran Church

We have passed our inspections, with the Greater Chicago Food Depository, twice this year. This inspection is now done on the computer and the information was lost the first time. The inspector looks for things like making sure our refrigeration units have thermometers and are numerically labeled. Food is kept 6 inches off the floor and varmint free. Required paper and signage is current completed. Paul Bucko passed his test and is now a certified Foodservice Manager with state of Illinois and the city of Chicago. The pantry now has three certificates.

Our flyer about the pantry is now written in Spanish. We are working on a Polish version. We are very blessed with volunteers; an average of 30 people on Monday and Thursday. Wednesday, clean up and delivery day, we usually have 6 volunteers.

We are making deliveries on every other Wednesday to between 10 and 14 homes. We are looking for more delivery persons.

We have special volunteers from Activision on Central and Envision Unlimited on Natchez. We will not be having a school supply day. Too many of our fellow organizations are passing out book bags and equipment. People are still giving us supplies and we will pass them out but we will not have an organized day.

Our Rescue Food program is doing very well. Jose and Carlos pick up donations from Jewel every Monday and Thursday. The program has given us the following: 5325 lbs. of dairy, 10,023 lbs. of meat, 13,799 lbs. of mixed food items, 675 lbs. of nonfood items, 1500 lbs. of prepared perishable food items. The United States Post Office collected over 800 pieces of nonperishable food items, this year. We sent thank you notes to Jamel Martinez, the manager of our Roger McCauliff branch and Louis DeJoy, the Washington D.C. Manager. They were very pleased with our acknowledgement of their service. The Post Office tries to collect food for us every year.

We have had very profitable fund raisers. We started the new year with our Hawaiian event at the Moose. We gained \$2410. At Buona Beef we earned \$246, Pot Belly netted the pantry \$619., and Super Dawg supported us with a donation of \$160. Our Empty Bowl fundraiser was extremely successful. Pastor Janine collected beautiful bowls from artists in our area which were sold for a donation. On a Sunday we also gave away bowls of soup at a wonderful get together, enjoying soup made by volunteers and community restaurants. We cleared \$5080.62. The Funds2Organization paid us for our 142 bags collected shoes. This fund raiser brought us \$1645. A special thank you to Pastor Jason and his parishioners for storing the collected bags at Montrose Baptist Church.

We are now using PayPal to collect donations. It has proven to be very helpful. Our holiday give aways were very successful. We gave away 73 Easter baskets, hand made by Joan. For Thanksgiving we gave away extra food for the holiday to 152 families. This Christmas we gave 103 children from 54 families two gifts each, one item that the child wanted and another that Mom thought the child needed. United in Faith, Portage Park Elementary School, and Thorp Elementary School were very generous with their donations. We also shared holiday food with 157 families.
